The manager of the accommodation facility is required to preserve this declaration for a period of five years, in order to permit for the tax controls conducted by the Municipality of Castiglione della Pescaia. The data processor is the Manager of tribute industry of the Municipality. In every moment you will be able to exercise your rights towards the manager of the accommodation facility, who receives this statement, and towards the Municipality of Castiglione della Pescaia, both in their capacity of data controller, as defined in article 7 of Leg.Decree no.196/2003.
